AN ORDINANCE OF THE CITY OF UNIVERSITY PARK, TEXAS, AMENDING THE SPECIAL SIGN DISTRICT GRANTED BY ORDINANCE 94/10 FOR THE UNIVERSITY CAMPUS-1 AND UNIVERSITY CAMPUS-2 ZONING DISTRICTS WHICH ARE THE PROPERTY OF SOUTHERN METHODIST UNIVERSITY, BY PERMITTING NEW SIGNS FOR A NEW PARKING LOT ON DANIEL AND FOR VARIOUS SIGNS AT GERALD J. FORD STADIUM; PROVIDING FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY OF FINE NOT TO EXCEED THE SUM OF FIVE HUNDRED (\$500.00) DOLLARS FOR EACH OFFENSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS the Zoning and Development Advisory Committee ("ZADAC") of the City has considered a request for amendment of the special sign district for Southern Methodist University, granted by Ordinance 94/10 and thereafter amended, and has recommended to the City Council the amendment of the ordinance; and

WHEREAS the provisions of the Sign Ordinance have been complied with and the City Council has provided notice and a public hearing about such request and recommendation and is of the opinion and finds that such special sign district should be amended as requested; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF UNIVERSITY PARK, TEXAS:

**SECTION 1.** The signs previously authorized for the special sign district for Southern Methodist University by Ordinance 94/10, as amended, are located by number on a map of the campus attached hereto as Exhibit "A1-Existing Sign Exhibit", and a description of each authorized sign by location, type, and the number of the ordinance approving is attached hereto as Exhibit "A2-Existing Sign Description."

**SECTION 2.** The ZADAC has considered the application for further amendment of the special sign district, as requested by Southern Methodist University (the "University"), to

authorize additional signage for the University campus as part of its overall graphics program. A map showing the location of each proposed additional sign is attached hereto as Exhibit "B1-Proposed Sign Amendment", and a description of each proposed sign by location and type is attached hereto as Exhibit "B2-Proposed Sign Description."

**SECTION 3.** A color rendering of the design details, content, and alternate event plate for proposed sign number 1 is attached hereto as Exhibit "C" (3 pages) and made part hereof for all purposes. Color renderings of the location, view, content, and relative scale of proposed signs numbered 2-11 is attached hereto as Exhibit "D" (5 pages) and made part hereof for all purposes.

SECTION 4. That such request was accompanied by maps, plans, drawings, and photographs which provide such details and specifications as were required by ZADAC and in the opinion of ZADAC, such graphics programs will result in the signage appearance of the area being beneficial to the public health, safety, and general welfare and in the interest of the City of University Park. ZADAC has recommended to the City Council that Ordinance 94/10 be further amended in part to permit the signs and items in accordance with the plan.

**SECTION 5.** After notice and public hearing, and in the best interest of the public health, safety and general welfare of the City, Ordinance 94/10, as amended, is hereby further amended in part by approval of Signs 1-11 as located, described, and depicted by Exhibits B1, B2, C, and D, and, in sequential order, made part of Section 3 A "Permitted Signs" of said Ordinance 94/10.

**SECTION 6.** All ordinances of the City of University Park in conflict with the provisions of this ordinance are hereby repealed.

**SECTION 7.** Should any sentence, paragraph, subdivision, clause, phrase, or section of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not

affect the validity of this ordinance, or any part or provision thereof other than the part thereof decided to be unconstitutional, illegal, or invalid.

**SECTION 8.** Any person, firm or corporation violating any of the provisions or terms of this ordinance shall be given the right to correct the violation within a seven-day period or otherwise shall be deemed guilty of a misdemeanor and, upon conviction in the Municipal Court of the City of University Park, Texas, shall be punished by a fine not to exceed the sum of five hundred (\$500.00) dollars for each offense, and each day such violation is continued shall be deemed to constitute a separate offense.

**SECTION 9.** This ordinance shall take effect immediately from and after its passage and the publication of the caption as the law and charter in such cases provide.






