He said that this was reviewed and recommended for approval by the Zoning and Development Advisory Committee at their January 21 meeting.

Consider approval of a Development Agreement between the City of University Park and Hillcrest/Daniel, Ltd.

Assistant City Manager Shanna Sims-Bradish said that this agenda item is related to the Snider Plaza sign that was just approved. She explained that this Development Agreement is between the City and the property owner, Hillcrest/Daniels, Ltd., and it stipulates responsibility in regards to the sign. The owner will be responsible for compliance with all City code requirements for installation of the sign and will pay for the operation, maintenance, repair and replacement of the sign. The City will have final approval over the proposed sign and will pay for the cost of fabrication and installation of the sign.

Conduct a public hearing regarding establishing a Specific Use Permit to construct a pickleball/sport court on private property. The property address is 2945 Stanford Avenue and is zone SF-3. PZ 26-001

Mayor Stewart opened the public hearing.

Director of Public Works Keegan Littrell said that this is a request from the owner of 2945 Stanford to build a pickleball court in their backyard. He said that staff chose to interpret that a pickleball court is the same as a tennis court in terms of zoning definitions.

He said that staff mailed out 21 notices to owners within 200 feet of the property. Nine notices were returned with seven in favor and two undecided. He said that the Planning and Zoning Commission conducted a public hearing at its meeting on January 13 and recommended that the City Council also conduct a public hearing and consider this request.

Councilmember Philbin asked if the neighbor to the east and neighbor directly across the alley received notification of this request. Keegan said yes, if they were within 200 feet.

Councilmember Rieman asked about noise from the court - she noted that the City has spent a lot of time trying to mitigate the noise from the Williams Park pickleball courts, so she's concerned about a court in a neighborhood surrounded by other homes.

There were no comments, so Mayor Stewart closed the public hearing.

Consider an ordinance revising the time limits for the Residential Parking designation in the 3200 block of Milton

Director of Public Works Keegan Littrell said that this is being brought before the Council a second time. The residents in the 3200 block of Milton requested that their Resident Only Parking designation change hours from Monday-Friday, 8 a.m. - 5 p.m., to all times.

He said that a majority of residents on the block were in favor of this change. At the January 6 meeting, the City Council denied the request. Since then, residents asked the Council to reconsider the decision.

Councilmember Philbin asked why only this block of Milton wants the enhanced hours. Keegan said that the residents complained about SMU gameday parking and students parking on the block.

Max Fuqua, 3219 Milton, asked the City Council to reconsider their request.

Donna Tomasi, 3208 Milton, said she wants the parking in front of her house to always be available to her and she complained about the trash generated from student parking.

Director of Public Works Keegan Littrell said that this ordinance abandons two easements at 3904 Lovers Lane to resolve an issue with the property owners related to a box culvert/storm sewer that crosses the property. He said that staff recommends abandoning the two easements and receiving one easement dedication.

Consider an ordinance designating school zones in University Boulevard, Park Street, Shannon Lane, and McFarlin Boulevard for the Highland Park Presbyterian Day School

Director of Public Works Keegan Littrell said that the Highland Park Presbyterian Day School requested school zones on University Boulevard, Park Street, Shannon Lane, and McFarlin Boulevard to enhance safety for the students and parents during drop off and pick up. The Code of Ordinances allows the Public Works Director to designate school zones. He said that the school has a mid-day break, so the proposed time panels are:

8:00 - 8:45 a.m.

11:45 a.m. - 12:05 p.m.

1:45 to 2:05 p.m.

He said that staff recommends designating school zones for the Highland Park Presbyterian Day School.

Consider an ordinance amending Section 2.01.005 'Keeping Fowl Prohibited' of the Code of Ordinances

Director of Public Works Keegan Littrell said that staff has received multiple complaints from residents about ducks being fed and harbored near Curtis Park. Reported issues include damage to landscaping and accumulation of animal waste on public and private property.

This proposed ordinance clarifies and reinforces the City's prohibition on keeping, feeding, or harboring specified fowl and provides an enforcement mechanism to address this issue citywide.

He said that the complaints from residents are about Muscovy ducks. The ducks are an invasive species in Texas.

Dan Coffman, 3443 Lovers Lane, said that over the past couple of years, the neighbors have had trouble with the Muscovy ducks traipsing through their yards and destroying landscape due to a resident who is feeding them daily. He said that the duck feed is also attracting rats. He asked the City to enforce the existing ordinance or perhaps amend it to facilitate enforcement so that this practice will be prohibited.

**A motion was made by Councilmember Melissa Rieman, seconded by Mayor Pro Tem Mark Aldredge, to approve this ordinance amending Section 2.01.005 'Keeping Fowl Prohibited' of the Code of Ordinances. The motion carried by the following vote:**
