A tax rate of \$0.238613 per \$100 valuation has been proposed by the governing body of the City of University Park.

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for the City of University Park from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that the City of University Park may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that the City of University Park is proposing to increase property taxes for the 2023 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 19, 2023 AT 05:00 PM AT City Hall, City Council Room, 2nd Floor, 3800 University Blvd, University Park, TX 75205.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, the City of University Park is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City Council of the City of University Park at their offices or by attending the public hearing mentioned above.
