

## **ORDINANCE NO.**

**AN ORDINANCE OF THE CITY OF UNIVERSITY PARK, TEXAS, LIMITING PARKING ON THE FORTY-SEVEN (47) PARKING SPACES ON THE SOUTH SIDE OF THE 3000 BLOCK OF DANIEL FROM DURHAM TO DUBLIN, THE TWENTY-SEVEN (27) PARKING SPACES ON THE WEST SIDE OF THE 6500 BLOCK OF DUBLIN FROM DANIEL TO UNIVERSITY, AND THE FORTY (40) PARKING SPACES ON THE NORTH SIDE OF UNIVERSITY FROM DURHAM TO DUBLIN FROM 12:01 A. M. TO 12:00 MIDNIGHT ON SEPTEMBER 6, OCTOBER 4, OCTOBER 11, NOVEMBER 1, AND NOVEMBER 22, 2025; RESERVING THE THIRTY-TWO PARKING SPACES ON THE EAST SIDE OF THE 6500 BLOCK OF DURHAM FROM UNIVERSITY TO DANIEL FOR PARK USE ONLY; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT; PROVIDING FOR A FINE NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE; AND PROVIDING AN EFFECTIVE DATE.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF UNIVERSITY PARK, TEXAS:**

**SECTION 1.** That it shall be unlawful and an offense for any person to leave unattended, stand, or park a motor vehicle in the forty-seven (47) parking spaces on the south side of the 3000 block of Daniel from Durham to Dublin, in the twenty-seven (27) parking spaces on the west side of the 6500 block of Dublin from Daniel to University, or in the forty (40) parking spaces on the north side of the 3000 block of University from Durham to Dublin from 12:01 a. m. to 12:00 midnight on September 6, October 4, October 11, November 1, and November 22, 2025.

**SECTION 2.** The thirty-two (32) parking spaces on the east side of the 6500 block of Durham from Daniel to University shall be limited to Burleson Park use only, with a two-hour time restriction, during the hours and days listed in section 1 above.

**SECTION 3.** All ordinances of the City of University Park in conflict with the provisions of this ordinance are hereby repealed.

**SECTION 4.** Should any sentence, paragraph, subdivision, clause, phrase, or section of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not

affect the validity of this ordinance or any part or provision thereof, other than the part decided to be invalid, illegal, or unconstitutional.

**SECTION 5.** Any person violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and, upon conviction in the municipal court of the City of University Park, Texas, shall be subject to a fine not to exceed the sum of two hundred dollars (\$200.00) for each offense. Any vehicle parked in violation of this ordinance may be towed to a designated impound location.

**SECTION 6.** That this ordinance shall take effect immediately from and after its passage and publication of the caption as the law and Charter in such cases provide. The parking regulations set forth herein shall be enforceable when appropriate signs have been erected and other reasonable means have been used to give notice of the limits set herein.
