AN ORDINANCE OF THE CITY OF UNIVERSITY PARK, TEXAS, AMENDING THE CODE OF ORDINANCES OF THE CITY OF UNIVERSITY PARK, CHAPTER 12, TRAFFIC CONTROL, BY AMENDING SECTION 12.05.042 (a) TO PROVIDE FOR DESIGNATION OF RESIDENT-PARKING-ONLY ZONES FOR THE SOUTHERN SIDE OF 4007-4005 NORMANDY AND THE EASTERN SIDE OF THE 6000 BLOCK OF NORMANDY AVENUE, THE NORTHERN PORTION OF THE 4000 BLOCK OF SHENANDOAH, THE WESTERN PORTION OF THE 6100 BLOCK OF ST. ANDREWS DRIVE, THE EASTERN PORTION OF THE 6000 BLOCK OF CONNERLY DRIVE, AND THE WESTERN PORTION OF THE 6100 BLOCK OF WESTWICK ROAD; PROVIDING THAT THE RESIDENT-ONLY RESTRICTIONS PROVIDING HEREIN SHALL BE EFFECTIVE 12 AM – 6:00 PM ON SATURDAY, 2:00 PM - 5:00 PM SUNDAY, AND AT ALL TIMES FROM MONDAY – FRIDAY; PROVIDING THAT THE CITY COUNCIL WILL REVIEW THE NEW RESIDENTIAL PARKING DISTRICT RESTRICTIONS SIX (6) MONTHS FOLLOWING THE EFFECTIVE DATE OF THIS ORDINANCE; PROVIDING PROVISIONS WHEREBY THE FIRST UNITARIAN CHURCH MAY REQUEST SUSPENSION OF THE RESIDENTIAL PARKING RESTRICTIONS PROVIDED HEREIN; AND PROHIBITING PARKING ON THE SOUTH-EASTERN PORTION OF 6101 ST. ANDREWS DRIVE; PROVIDING FOR THE ERECTION OF SIGNS PROVIDING NOTICE OF THE RESIDENTIAL PARKING RESTRICTIONS AND "NO PARKING" ADOPTED HEREIN; PROVIDING FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING FOR A PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF UNIVERSITY PARK, TEXAS:

SECTION 1. That Chapter 12, Article 12.05 "Parking", Section 12.05.042 (a), of the Code of Ordinances, City of University Park, Texas, is hereby amended in part to designate additional resident-parking-only zones, as follows:

"Sec. 12.05.042 Zones Designated; issuance of permits

- (a) The following are designated as resident-parking-only zones, to wit:
- (19) The 3000, 3100, 3200 and 3300 blocks of Milton;
- (20) The 3400 block of Normandy, except the south side west from Hillcrest a distance of 215 feet; the southern side of 4007-4005 Normandy and the eastern side of the 6000 block of Normandy Avenue, provided that the resident-only restriction

for 4007-4005 Normandy and the 6000 block of Normandy shall be effective 12 am -6:00 pm on Saturday, 2:00 pm -5:00 pm Sunday, and at all times from Monday - Friday;

- (21) The 3000–3300 blocks of Rosedale, provided that the resident-parking-only restriction for the 3000 blocks of Rosedale shall be effective from 8:00 a.m. to 5:00 p.m. daily;
- (22) The 3400 block and the northern portion of the 4000 block of Shenandoah, provided that the resident-only restriction for northern portion of the 4000 block of Shenandoah shall be effective 12 am 6:00 pm on Saturday, 2:00 pm 5:00 pm Sunday, and at all times from Monday Friday;
- (23) The 2900–3100 and 3400 blocks of University Blvd.;
- (24) On the south side of the 4100 block of Glenwick, from Preston Road west a distance of two hundred twenty feet (220');
- (25) The western portion of the 6100 block of St. Andrews Drive, provided that the resident-only restriction for the western portion of the 6100 block of St. Andrews Drive shall be effective 12 am 6:00 pm on Saturday, 2:00 pm 5:00 pm Sunday, and at all times from Monday Friday;
- (26) The eastern portion of the 6000 block of Connerly Drive, provided that the resident-only restriction for the eastern portion of the 6000 block of Connerly Drive shall be effective 12 am 6:00 pm on Saturday, 2:00 pm 5:00 pm Sunday, and at all times from Monday Friday;
- (27) The western portion of the 6100 block of Westwick Road, provided that the resident-only restriction for the eastern portion of the 6100 block of Westwick Road shall be effective 12 am 6:00 pm on Saturday, 2:00 pm 5:00 pm Sunday, and at all times from Monday Friday;

SECTION 2. The City Council will review the new Residential Parking District requirements provided for herein six (6) months following the effective date of this Ordinance.

SECTION 3. The First Unitarian Church may request a suspension of the Residential Parking District (RPD) Requirements provided for herein in accordance with the following:

(1) The request for suspension of the RPD must be scheduled, with no less than

- three (3) day advance notice to the City;
- (2) Suspension of the RPD Requirements will be limited to ten (10) special events per calendar year, with a maximum duration of four (4) hours per event;
- (3) The RPD Requirements shall be suspended on the following holidays, provided a minimum of three day advance notice is provided to the City:
 - a. Maundy Thursday
 - b. Good Friday
 - c. Easter Sunday
 - d. Christmas Eve
 - e. Christmas Day
- (4) The RPD Requirements may be suspended with less than three (3) days advance notice for funerals or other local tragedies, provided the City is notified as soon as possible;
- (5) Upon suspension of the RPD Requirements:
 - a. The City will notify residents via the City's "group" e-mail
 - b. The City will cover/uncover signs during normal working hours
 (Monday Friday, 7 am 5 pm), at the City's expense
 - c. The First Unitarian Church will cover/uncover signs outside of the City's normal working hours, at the Church's expense

SECTION 4. It shall be unlawful and an offense for any person to leave, stand or park any motor vehicle at any time on the south-eastern portion of 6101 St. Andrews Drive.

SECTION 5. That all provisions of the Code of Ordinances of the City of University Park, Texas, in conflict with the provisions of this ordinance are hereby repealed.

SECTION 6. That should any word, sentence, paragraph, subdivision, clause, phrase or

section of this ordinance or of the Code of Ordinances, as amended hereby, be adjudged or

held to be void or unconstitutional, the same shall not affect the validity of the remaining

portions of said ordinance or the Code of Ordinances, as amended hereby, which shall remain

in full force and effect.

SECTION 7. Any person, firm or corporation violating any of the provisions of this

ordinance shall be deemed guilty of a misdemeanor and, upon conviction in the municipal

court of the City of University Park, Texas, shall be punished by a fine not to exceed the sum

of two hundred dollars (\$200.00) for each offense.

SECTION 8. That this ordinance shall take effect immediately from and after the

publication of the caption, as the law and Charter in such cases provide, subject to the erection

of appropriate signs giving notice of the resident-parking-only zone provided for in Section 1

herein and erection of appropriate signs giving notice of "No Parking" as provided in Section

4 herein.
