"IF YOU ARE CONVICTED OF A MISDEMEANOR OFFENSE INVOLVING VIOLENCE WHERE YOU ARE OR WERE A SPOUSE, INTIMATE PARTNER, PARTNER, PARENT, OR GUARDIAN OF THE VICTIM OR ARE OR WERE INVOLVED IN ANOTHER, SIMILAR RELATIONSHIP WITH THE VICTIM, IT MAY BE UNLAWFUL FOR YOU TO POSSESS OR PURCHASE A FIREARM, INCLUDING A HANDGUN OR LONG GUN, OR AMMUNITION, PURSUANT TO FEDERAL LAW UNDER 18 U.S.C. SECTION 922(G)(9) OR SECTION 46.04(B), TEXAS PENAL CODE. IF YOU HAVE ANY QUESTIONS WHETHER THESE LAWS MAKE IT ILLEGAL FOR YOU TO POSSESS OR PURCHASE A FIREARM, YOU SHOULD CONSULT AN ATTORNEY."

Warning: If you fail to comply with the terms of the judgment and the delinquent debt is sent to a collections agency, a fee of 30% of the total amount will be added to the judgment.

## ENTER A GUILTY OR NO CONTEST PLEA BY MAIL

Select a plea and sign the statement at the bottom of this page. Mail to the municipal court a copy of the citation and a check, cashier's check or money order for the full amount made payable to the City of University Park. DO NOT MAIL CASH. If payment is received by the Clerk prior to your court setting, it will not be necessary to appear in open court.

#### ENTER A GUILTY OR NO CONTEST PLEA IN PERSON

You.may pay in person at the University Park Municipal Court Clerk's office, Monday through Friday, 8:00 a.m. to 5:00 p.m. Cash, check, money order or credit card will be accepted as a form of payment. Only the defendant or attorney on file may enter a plea. Defendant's parents or guardians may not enter a plea or attend court in place of the defendant.

ENTER A NOT GUILTY PLEA If you wish to plead NOT GUILTY, you must appear on the date and time shown on your citation, or enter a plea by mail on or before your court date. Failure to enter a plea will result in an increased fine, and a warrant will be issued for your arrest.
