As of February 2, 2017, the Foundation had \$123,921.96 in its checking account, and \$39.57 in its money market account.

4. Appoint a new Director for 2017 – 2018. Current directors and their office:

Dawn Moore – President (director term: 2013 – 2015, held over to 2016)

Taylor Armstrong – Vice President (director term: 2016- 2018) Gage Prichard – Secretary/Treasurer (director term: 2016-2018)

Each Councilperson normally serves a term of three years on the Board, and then rotates off. However, in 2016 two Board members left due to Council term expirations and the third Board member had already served three years. To provide continuity to the Board, Mayor Pro Tem Dawn Moore graciously held over in her office an additional year.

It has been the tradition of the Board to appoint the next most senior Council member (who has not yet served) to the UPCF Board. Following this practice, the next prospective appointee is Councilman Randy Biddle.

The Board would like to thank Councilperson Moore for her service.
