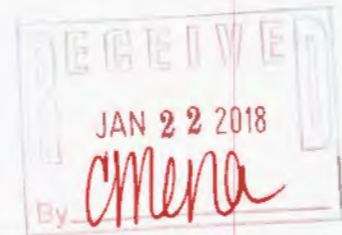

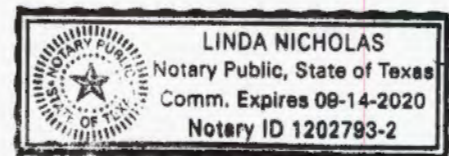

We occasionally host Gatherings on weekends focused on the SMU schedule, such as Homecoming + Parents weekend.
