THENCE NORTH 01'31'25" WEST ALONG THE EAST RIGHT-OF-WAY LINE OF SAID HURSEY AVENUE, A DISTANCE OF 140.00 FEET TO AN "X" FOUND FOR CORNER AT THE NORTHWEST CORNER OF SAID LOT 6;




