SUBJECT: CONSIDER AND ACT: on an ordinance establishing the Over-65 and

Disabled Homestead Exemption amount at \$425,000

BACKGROUND:

Since 2008, the University Park City Council has set the City's over-65 and disabled property tax exemption at an amount approximating 25% of the average single-family home market value established during the previous tax year. This practice is consistent with the City's Financial Management Policies.

The chart below displays the yearly changes in the value of an average single-family home, and the related exemption over a ten-year period:


The market value of the average, single-family ("A11") home in University Park increased to \$1,699,817 in calendar 2020. Multiplying this amount by 25% yields \$424,954, or \$425,000 (rounded to the nearest whole thousand).



The Finance Advisory Committee reviewed the exemption calculation during their meeting of April 15, 2021. At that meeting, they affirmed the calculation method and voted in favor of the exemption increase.





The scale on the left (green bar scale) is the average A11 (single-family) home value, while the scale on the right (red line scale) is the value of the exemption. The value of the exemption "trails" the average home value by one year.

RECOMMENDATION:

Consistent with the City's financial policies and past practices, City staff recommends the exemption amount be increased from the current \$417,000 to \$425,000.

If approved by the City Council, City staff will communicate the change to the Dallas Central Appraisal District for inclusion in the computation of the 2021 certified tax roll.
