A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF UNIVERSITY PARK, TEXAS, AMENDING RESOLUTION 08-18, MASTER FEE RESOLUTION, NOW CODIFIED IN APPENDIX A OF THE CODE OF ORDINANCES BY AMENDING SUBSECTION A3.011 – SCHEDULE OF DRAINAGE CHARGES AS DETAILED ON EXHIBIT A; RATIFYING COLLECTIONS MADE BETWEEN OCTOBER 1ST AND OCTOBER 5TH; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, The City Council of the City of University Park adopted a number of budgeted fee schedule changes for fiscal year 2022, and

WHEREAS, the Storm Water fee changes as detailed in Exhibit A were inadvertently left off the list of changes adopted at the City Council meeting of September 21, 2021, and

WHEREAS, it is in the best interest of the City to enact all necessary budgeted fee schedule changes at the start of the new fiscal year,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF UNIVERSITY PARK, TEXAS:

SECTION 1. That subsection A3.011 of Appendix A of the Code of Ordinances (the “Fee Schedule”) is hereby amended as follows on Exhibit A.

SECTION 2. This Resolution shall take effect as of October 1, 2021.

SECTION 3. Any associated Storm Water revenues collected between the effective date noted above, and the date of passage are hereby ratified by the City Council.
