A work session was opened at 4:30 PM in the Council Conference Room by Chairman Bob West.

Mrs. Rees introduced PZ 17-007 to amend Planned Development District PD-17 and approve a detailed site plan to add an addition to the northwest corner of the existing high school located at 4220 Emerson Avenue. Mrs. Rees provided a brief PowerPoint presentation and offered renderings of the site, setbacks, and height information. A brief discussion was held regarding fire codes, the request for additional architectural design, the distance between the main building and the visitor stands, and the layout of the building with the proposed additions. Jonathan Aldis, with Stantec Architecture, offered his input regarding the addition of head-in parking, the screening of dumpsters, and the additional landscape. The Commissioners discussed the responses that were received from residents, coverage calculations, and the construction timeline and schedule.

The work session was closed at 4:53 PM.
