#### IV. MAIN AGENDA

#### <u>21-074</u>

Consider an ordinance designating Residential Parking Only in the 3400 block of Milton.

Director of Public Works Jacob Speer said that this request to designate the north curb line of the 3400 block of Milton as Residential Parking Only was made by the residents of 3420 Milton in anticipation of the closure of their alley due to the Snider Plaza utility construction project. He said that at Council's direction, Public Works distributed petitions to residents and property owners of the 3400 block of Milton. Staff received 12 responses to the petition, with 11 in favor and one opposed.

Jacob said that recommends designating the north curb line of the 3400 block of Milton as Residential Parking Only for residents of 3420 Milton. Once construction is complete and the alley is accessible, the Residential Parking Only designation will be removed.

A motion was made by Mayor Pro Tem Randy Biddle, seconded by Councilmember Liz Farley, to adopt this ordinance designating Residential Parking Only in the 3400 block of Milton. The motion carried by the following vote:
